

RESOLUTION 13-22 – AMENDED
Elected Officials Salaries

Whereas, during the FY23 budget review process, the Floyd County Board of Supervisors (Board) has considered salaries for elected officials and are required to set those salaries prior to approving the county budget;

Whereas, the Floyd County Compensation Board meets annually to recommend a compensation schedule for elected officials for the fiscal year immediately following, in accordance with Iowa Code Chapters 331.905 and 331.907, and made salary recommendations for elected officials for the fiscal year beginning July 1, 2022 per the schedule below, and

Elected Official	Current FY22 Salary	% Increase	Recommended FY23 Salary
Attorney	\$108,576	6%	\$115,091
Auditor	\$69,842	6%	\$74,033
Recorder	\$69,615	6%	\$73,792
Treasurer	\$69,615	6%	\$73,792
Sheriff	\$92,597	12%	\$103,709
Supervisor	\$40,098	5%	\$42,103

Whereas, the Board may decrease the Compensation Board’s recommendations for all elected county officials by an equal percentage and may reduce the recommendation for the Supervisor’s salary irrespective of the recommended compensation paid to other elected county officers, and on February 14, 2022, voted to reduce the 5% recommended increase for the Supervisors to 0%; and

Whereas, the Board requires assistance in duties such as preparing the county budget pursuant to Iowa Code 331.434, assisting with various grants, and other administrative duties, and have determined that Gloria Carr, Floyd County Auditor, has the requisite expertise and experience to assist and should be compensated a token stipend for her assistance above the County Auditor duties per Iowa Code 331.502;

Now therefore, be it resolved that the Floyd County Board of Supervisors has reduced the recommendation of the Compensation Board by 16 2/3% for the Attorney, Auditor, Recorder, Treasurer and Sheriff and now formally adopts the following salary for county elected officials for the fiscal year beginning July 1, 2022:

Auditor	\$73,334 + \$1,000 stipend = \$74,334
Recorder	\$73,096
Treasurer	\$73,096
Sheriff	\$101,857
Supervisor	\$40,098

Be it resolved, Res #13-22 approved on March 28, 2022 erroneously stated the adopted FY23 salary for the Sheriff and is hereby rescinded and replaced with this Res #13-22 – AMENDED.
